

Bangarra Dance Theatre “Buy and Win” Sheltering Promotion (Sydney).

Terms and Conditions

These terms and conditions (“Terms”) govern participation in the Bangarra Dance Theatre's “Buy and Win” *Sheltering* Promotion (“Competition”) for the *Sheltering 2026* season in Sydney. By entering, entrants agree to be bound by these Terms.

1. Promoter

The promoter is Bangarra Dance Theatre Australia Ltd (“Bangarra”), ABN 96 003 814 006, located at Wharf 4/5, 15 Hickson Road, Walsh Bay, 2000.

2. Eligibility

- Entry is open to Australian residents aged 18 years or older, excluding employees of Bangarra Dance Theatre and their immediate families.
- To enter, participants must purchase a ticket to *Sheltering 2026* in Sydney via the Bangarra website (bangarra.com.au) during the promotional period specified for each city.
- All entries must be new bookings made between the dates provided. Refunds and exchanges of existing bookings are not eligible for entry.
- Tickets purchased through any other channel or website are not valid for entry.

3. Promotional Period
