Surrounded by natural beauty and elements exposed along the heritage-listed Wharves, Dangarra O Badu (Dharug/Eora language for “Dancing on Water”) is a one-of-a-kind space with an outdoor patio facing the beautiful waters of Warrane (Sydney Harbour).

Our newly renovated, state-of-the-art facility will provide you and your guests with all the modern amenities you ensure your day runs smoothly. And an experienced venue manager is here to help you every step of the way.

## Studio 1

---

Studio 1 is a rehearsal, theatre, or conference space, with a 120-seat retractable seating bank (with the ability to extended to 160 seats), options for natural light or full blackout and an overhead lighting grid.

Studio 1 has the option of natural light or can be a fully blacked out space. Please note no stiletto shoes or sharp furniture/ scenery items, that could damage the tarkett floor, will be allowed without a secondary floor.

## Things to Know

### EVENT TIMES

The glass doors to the patio must be closed by 10pm. Events must finish by 11pm with bump-out finished and all persons off-site by 11.30pm.

### BUMP IN & BUMP OUT

Quotes include bump-in and bump-out time. Please provide these times to the Venue Manager when making arrangements for your event.

### TERMS & CONDITIONS

Your booking is only confirmed when you have paid a deposit and signed the contract.

### SECURITY

Receptions serving alcohol for over 50 guests require 1 x security guard per 50 people.

### DELIVERIES

Outside of your event times, deliveries can be made Monday-Friday 9am-5pm

As a heritage listed building of great historical and cultural importance, there are several key considerations when hosting your event at Bangarra Dance Theatre. Please ensure your event team and guests are aware of the following;



There is no smoking or vaping permitted anywhere on the wharf



Sound decibel limit is 87 inside, 65 outside



There is no open flame permitted on the wharf (including candles)



No rice, confetti, or equivalent small particles are permitted to be thrown



Alcohol is permitted outside of the venue ONLY in the designated bollarded area on the North side of the Wharf



Nothing may be taped, tacked, or rigged to the walls or flooring of the venue. Any décor must be free-standing

# Frequently Asked Questions

---

- 1. What is the deposit required to book the venue and when is it due?**  
A bond payment of \$1000 is due upon quote approval in order to confirm your booking.
- 2. What are the payment options available?**  
Payment can be made via EFTPOS, bank transfer, or credit card over the phone.
- 3. What is the cancellation policy?**  
Cancellation fees will be payable according to the following schedule:  
*More than 6 months*  
Full refund of payment received  
*Between 6 - 3 months*  
50% of deposit retained by Bangarra  
*Between 3 months - 2 weeks*  
Full deposit retained by Bangarra  
*Less than 2 weeks*  
Full hire fee retained by Bangarra
- 4. Is there a minimum number of hours required to book the venue?**  
Bookings must be made for a minimum of 4 hours.
- 5. What is the venue's policy on outside vendors and catering?** Food & beverage must be supplied by one of our approved caterers. All other service vendors are welcome to be as your preference.
- 6. Is there parking available?**  
Street parking is available on Hickson Road (metred) or Barangaroo Point Car Park, Barangaroo Reserve Car Park, and Bond One Car Park are all within 5 minutes walking distance.
- 7. Is the venue wheelchair accessible?**  
The venue is wheelchair accessible, though you may wish to visit the venue ahead of time to ensure the floors are appropriate for any guests with accessibility requirements. There is an accessible ramp outside Sydney Dance Company leading to our entrance on Wharf 4/5.  
Our entrance, Function Space and facilities are all on ground level with level access. There is an accessible bathroom on the ground floor.
- 8. What is the policy on alcohol and music?**  
Alcohol is permitted via arrangement with any of our catering suppliers. This includes requests for BYO alcohol (corkage fees apply). Music is permitted at a maximum of 85 dB inside and 67 dB outside. This limit is monitored during events.
- 9. Are there any restrictions on decor or decorations?**  
There is no open flame permitted on the Wharf. No rice, confetti, or equivalent small particles are permitted to be thrown. Nothing may be taped, tacked, or rigged to the walls or flooring of the venue, any décor must be free standing.
- 10. Can I visit the venue in person before booking?**  
Yes, we encourage visiting the venue in person before booking, by prior arrangement with our Venue Manager.
